# WAIVER AND RELEASE OF LIABILITY

Participants and parents/guardians of minors must recognize that there is an inherent risk of injury when choosing to participate in recreational programs. As such, you are solely responsible for determining if you and/or your minor child/ward are physically fit and/or adequately skilled for the activities contemplated by this Waiver and Release Agreement (this "Agreement"). It is always advisable to consult a physician before undertaking any physical activity.

### **Waiver and Release of All Claims and Assumptions of Risk:**

Please read this form carefully and be aware that in signing, you will be expressly assuming the risk and legal liability and waiving and releasing all claims for injuries, damages or loss which you or your minor child/ward might sustain as a result of participating in any and all activities connected with and associated with this program.

In consideration of the risk of potential injury in connection with my child/ward's participation in the [Summer Sports Series to be held at the Lewes Public Library (the "Program"), and as consideration for the right to participate in any and all of the Program's anticipated activit(ies) (the "Activity"), I hereby, for myself and my personal representatives knowingly and voluntarily enter into this Agreement agree to waive any and all rights, claims or causes of action of any kind whatsoever arising out of mine or my child/ward's participation in the Activity.
2. I certify that I am fully competent and my child/ward is in good physical condition, and have no medical or physical conditions that would restrict his/her participation in the Program or the Activity.
3. I further hereby release and forever discharge the Lewes Public Library, including its board of commissioners, employees, volunteers, members, agents, and any sponsors or advertisers for any physical or psychological injury that may be sustained as a direct result of participating in the Activity[, including traveling to and from an event related to the Activity.

4. I agree to indemnify and hold harmless the Lewes Public Library against any and all claims, suits or actions of any kind whatsoever for liability, damages, compensation or otherwise brought by me or anyone on my behalf, including attorney's fee and any related costs, if litigation arises pursuant to any claims made by me or by anyone else acting on my behalf.
  
5. I acknowledge that Lewes Public Library and its directors, officers, volunteers, representatives and agents are not responsible for errors, omissions, acts or failures to act of any party or entity, conducting a specific event or Activity.
