Minutes of October 28, 2025

*Call to Order at 10:25 a.m. by Chanta Howard-Wilkinson

A. Minutes of the September 23, 2025, Regular Meeting & Executive Session

It was moved and seconded to approve the minutes of the September meeting. The motion passed unanimously.

B. Financial Reports

Jill reported that the 5-year capital maintenance plan is being updated. It was moved and seconded to approve the financial reports. The motion passed unanimously.

C. Fundraising Update Report

There was discussion surrounding the board's \$9,000 challenge. It was agreed that \$250-level donors will be challenged to donate an additional \$250 to get the match. This leaves open the possibility of having a spring campaign for the pavilion and possibly a day of giving, possibly on Valentine's Day. It was moved and seconded to approve the Fundraising Update Report. The motion passed unanimously.

*Director's Report-Jill DiPaolo

The machine that tracks daily traffic malfunctioned, so there are no numbers for the History Book Festival, but it was clear that the event was well attended and hugely successful.

Updates to the large meeting room are nearly complete.

Repairs to the cracks in the pavilion floor are being made.

Jill is working with staff on the reorganization.
